**RESOLUTION NO. 346, s-2011**

**“A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION OF HIJO AGRARIAN REFORM BENEFICIARIES COOPERATIVE (HARBCO) AS NON-GOVERNMENT ORGANIZATION IN THIS CITY.”**

**WHEREAS**, Article 62, Rule XII of the Implementing Rules and Regulations of the Local Government Code of 1991 provides that the LGU shall promote the establishment and operation of people’s organizations, non-government organizations and the private sector to make them active partners in the pursuit of local autonomy;

**WHEREAS**, in furtherance of law and policy relative to the participation of non-government organizations in the promotion of participatory local governance and in the pursuit of local autonomy, DILG MC No. 2001-89 provide for the guidelines and procedure in the accreditation;

**WHEREAS**, the HIJO Agrarian Reform Beneficiaries Cooperative ( HARBCO ) a Multi-Purpose Agricultural Cooperative producing Export – Quality Cavendish Bananas since 1996 with its new Certificate of Registration No. 9520 – 11002482, under Article 144 of Republic Act 9520, otherwise known as the “Philippine Cooperative Code of 2008”, shall apply for accreditation as Non–Government Organization in the City of Tagum;

**WHEREAS**, after thorough review of the documents submitted to this august body per Committee Report No. 2, s-2011, the Agrarian Reform Beneficiaries Cooperative ( HARBCO ) has substantially complied with the requirements for accreditation;

**NOW THEREFORE**, be it resolved by the 5<sup>th</sup> City Council of Tagum to approve the application for accreditation of HIJO Agrarian Reform Beneficiaries Cooperative as Non-Government Organization in this city.

**RESOLVED FURTHER**, that copies of this resolution be furnished to HIJO Agrarian Reform Beneficiaries Cooperative and to all offices concerned for their information and guidance.
