RESOLUTION NO. 867, S-2009

A RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT XI THRU THE REGIONAL EXECUTIVE DIRECTOR, ASSISTANT SECRETARY ROGER C. CHIO, FOR A FUNDING ASSISTANCE IN THE AMOUNT OF FOURTEEN MILLION PESOS (P 14,000,000.00) FOR THE CONSTRUCTION OF THE RICE SEED STORAGE FACILITY SITUATED AT SITIO MANDAPAAN, BARANGAY NEW BALAMBAN, THIS CITY.

WHEREAS, RA 8435 otherwise known as the Agriculture and Fisheries Modernization Act or AFMA aims to strengthen the Agriculture and Fishery sectors through modernization and greater participation among the Local Government Units (LGUs), farmers and fisherfolks, non-government organization and people's organizations;

WHEREAS, the Local Government Code of 1991 allows the Department of Agriculture (DA), a national agency, to implement nationally funded projects through joint undertakings with Local Government Units (LGUs);

WHEREAS, three of the major thrusts of the city government under Hon. Rey T. Uy, City Mayor, are Agricultural Productivity/Livelihood Development & Promotion, Environmental and Tourism Development and Employment Generation which shall all contribute to the attainment of sustainable food security and poverty program of the city;

WHEREAS, under the Agricultural Productivity Program Thrust of the present administration the featured undertakings are the Hybrid Rice Seed Production and the

WHEREAS, the rice seeds storage facility shall be constructed in a property owned by the City Government of Tagum situated at Sitio Mandapaan, Barangay New Balamban, Tagum City.

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum City to request the Department of Agriculture Regional Field Unit XI thru Regional Executive Director, Assistant Secretary Roger C. Chio, for a funding assistance in the amount of Fourteen Million Pesos (P 14,000,000.00) for the construction of the rice seed storage facility situated at Sitio Mandapaan, Barangay New Balamban, this city.
