A RESOLUTION APPROVING THE APPLICATION FOR REVALIDATION OF PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE (PALC) OF SUBDIVISION PROJECT OF TAGUM CEBOLE HOMEOWNERS ASSOCIATION, INC. CONTAINING AN AREA OF 15,000 SQUARE MATERS LOCATED AT PUROK ANAHAW, BARANGAY VISAYAN VILLAGE, TAGUM CITY

WHEREAS, the application for Final Development Permit of Tagum Cebole Homeowners Association Inc. represented by Mrs. Marisa C. Camanzo, was represented for consideration and appropriate action;

WHEREAS, Rules and Regulations for subdivision projects direct all developers the filling of applications for Preliminary Approval and Locational Clearance (PALC) to the Local Government Unit concerned which shall be valid for a period of one hundred eighty (180) days only from date of approval, otherwise revalidation shall be applied;

WHEREAS, the Committee found out that the association has been granted PALC by the Sangguniang Panlungsod of Tagum on April 14, 2008 through Resolution No. 287 which date is already beyond the period specified in the rule s within which to submit and process application for final approval/development permit, hence revalidation is on order;

WHEREAS. Paragraph 2 (x) Section 447 of Republic Act 7160. otherwise known

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to approve the application for Revalidation of Preliminary Approval and Locational Clearance of subdivision project of Tagum Cebole Homeowners Association, Inc. containing an area of 15,000 square meters, located at Purok Anahaw, Barangay Visayan Village, Tagum City.
