RESOLUTION NO. 976, S- 2009

A RESOLUTION GRANTING DEVELOPMENT PERMIT UNDER BP 220 TO TAGUM CEBOLE HOMEOWNERS ASSOCIATION, INC. AS REPRESENTED HEREIN BY MRS. MARISA C. CAMANZO FOR A SUBDIVISION CONTAINING AN AREA OF 15,000 SQUARE METERS, LOCATED AT PUROK ANAHAW, BARANGAY VISAYAN VILLAGE, TAGUM CITY.

WHEREAS, the Office of the City Mayor has endorsed the application for a development permit of Tagum CEBOLE Homeowners Association, Inc. including its subdivision development plan on November 17, 2009 to this august body;

WHEREAS, the submitted development plan satisfactorily complied with the minimum requirements set in Section 10, Rule 111 of the Revised Implementing Rules and Standards for Economic and Socialized Housing as manifested in the Local Zoning Board Site Inspection and Evaluation Report dated June 26, 2008;

WHEREAS, Paragraph 2 (x) Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod subject to national law, to process and approve subdivision plans for residential, commercial or industrial purposes;

WHEREAS, it is incumbent to this august body to grant the Development Permit of the said applicant;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to grant the Development Permit under BP 220 to Tagum CEBOLE Homeowners Association, Inc. as represented herein by Mrs. Marisa C. Camanzo for a subdivision containing an area of 15,000 square meters, located at Purok Anahaw, Barangay Visayan Village, Tagum City.
