RESOLUTION NO. 987, s-2009

A RESOLUTION AUTHORIZING THE CITY VICE MAYOR, HON. ALLAN L. RELLON, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE SANGGUNIANG PANLUNGSOD A CONTRACT OF SERVICE WITH THE UNIVERSITY OF MINDANAO BROADCASTING NETWORK (UMBN-DXDN) FOR THE REMOTE LIVE COVERAGE OF THE WEEKLY SESSIONS OF THE SANGGUNIANG PANLUNGSOD OF TAGUM.

WHEREAS, it is the right of every citizen in this City of Tagum to be informed of the resolutions and ordinances passed by the members of the Sangguniang Panlungsod;

WHEREAS, radio broadcast is one of the fastest medium for mass communication to constituents of the city;

WHEREAS, by having a regular program in the conduct of regular and special sessions of the Sangguniang Panlungsod of Tagum, the people can easily avail of information on the approved laws, react about certain policies and development, and be updated about programs and projects of the City Government of Tagum and other concerns and issues;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Vice Mayor, Hon. Allan L. Rellon, to enter into and sign for and in behalf of the Sangguniang Panlungsod a contract of service with the University of Mindanao Broadcasting Network (UMBN-DXDN) for the remote live coverage of the weekly sessions of the Sangguniang Panlungsod of Tagum.

RESOLVED FURTHER, that the full text of the contract of service shall read as follows:

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

THE CONTRACT OF SERVICE WITH THE UNIVERSITY OF MINDANAO BROADCASTING NETWORK

The **UNIVERSITY OF MINDANAO BROADCASTING NETWORK– DXDN (UMBN-DXDN)**, hereinafter represented by its **Station Manager, Ms. AURORA A. LOZADA**, hereinafter called as the PARTY OF THE SECOND PART.

WITNESSETH:

WHEREAS, the PARTY OF THE FIRST PART is desirous to give information to the constituents of the city on the actual deliberation in the Sangguniang Panlungsod weekly sessions. The entire session deliberation will be aired live through the AM Radio Station that can cover the whole City of Tagum. It enables the public to know the works and functions of their elected public officials as legislators.

NOW THEREFORE, for and in consideration of the above premises, the herein parties have agreed:

1. That the PARTY OF THE SECOND PART with the entire crew, facilities and standby announcer will air the deliberation of the Sangguniang Panlungsod weekly session every Monday from 9:00 a.m. to 12:00 noon. In case the session will go beyond 12:00 noon, it will be tape recorded and to be aired the following day at the same time as continuation of the session.
2. Special sessions will be aired as Bonus from the PARTY of the SECOND PART.
3. That for and in consideration of the said service, the PARTY OF THE SECOND PART shall receive a package payment in the amount of TWENTY FIVE THOUSAND PESOS (P 25,000.00) per month.
4. That the format of the live coverage shall require the standby announcer to interview any member of the legislative body before the session, during recess and after the session to clarify some important measures being deliberate during the session.
5. That this contract shall have a term from January 1, 2010 to December 31, 2010 and renewable at the option of the PARTY OF THE FIRST PART. Further, this contract may be terminated by the PARTY OF THE FIRST PART even without or against the consent of the PARTY OF SECOND PART when the exigencies of the public service so requires it.
