**A RESOLUTION GRANTING DEVELOPMENT PERMIT UNDER BP 220 TO RENZO VILLAGE AS REPRESENTED HEREIN BY MR. LORENZO S. ANG FOR A SUBDIVISION WITH HOUSING COMPONENT CONTAINING AN AREA OF 44,572 SQUARE METERS LOCATED AT PUROK COGON, BARANGAY VISAYAN VILLAGE, TAGUM CITY**

**WHEREAS**, the Office of the City Mayor has endorsed the application of Mr. Lorenzo S. Ang for approval of a subdivision development plan which includes documents required in the process of development permit and was referred to the Committee on Housing on December 7, 2009;
