RESOLUTION NO. 830, S-2009

“A RESOLUTION HUMBLY REQUESTING THE NATIONAL ELECTRIFICATION ADMINISTRATION (NEA) TO PUBLISH THE VACANT POSITION OF GENERAL MANAGER OF THE DAVAO DEL NORTE ELECTRIC COOPERATIVE, INC (DANECO) FOR PUBLIC INTEREST AND TRANSPARENCY AND COMPLIANCE TO THE ELECTRIC POWER INDUSTRY REFORM ACT (EPIRA LAW)”.

WHEREAS, as the position of General Manager of the Davao del Norte Electric Cooperative, Inc. was vacated due to the untimely death of then General Manager, Edgardo D. SAvellano last June 19, 2009, the need to declare the said position vacant is deemed necessary;

WHEREAS, DANECO, being the sole electric power service provider in the Provinces of Compostela Valley and Davao del Norte except Panabo City and the Municipalities of Sto. Tomas, Carmen and Braulio E. Dujali, its services depend significantly on the competence and efficiency of its General Manager, with utmost dedication to public service;

WHEREAS, the rationale of NEA Memorandum No. 2004-022 dated October 21, 2004 states that the selection, hiring and termination of service/suspension of a General Manager are some of the most sensitive procedures in an Electric Cooperative, to promote transparency and prevent complications that may arise from the conduct of such procedures, a uniform set of standards for the selection, hiring and termination of service/suspension of a GM, to be followed by all EC's is instituted by the NEA;

WHEREAS, under paragraph a) of the aforesaid memorandum on the selection,

WHEREAS, Section 58, Paragraph B & C of Republic Act No. 9136 mandates the National Electrification Administration (NEA) to develop and implement programs, to strengthen the technical capability and financial viability of rural electric cooperatives, and to review and upgrade regulatory policies with a view of enhancing the viability of rural electric cooperatives as electric utilities;

NOW THEREFORE, BE IT resolved by the Sangguiang Panlungsod of Tagum to humbly request the National Electrification Administration (NEA) to publish the vacant position of General Manager of the Davao del Norte Electric Cooperative Inc. (DANECO) for public interest and transparency and compliance to the Electric Power Industry Reform Act (EPIRA LAW).

RESOLVED FURTHER, that a copy of this resolution shall be furnished to the National Electrification Administration (NEA) office at Quezon City, Metro Manila.
