RESOLUTION NO. 947, S-2009

A RESOLUTION AUTHORIZING THE CITY VICE MAYOR OF TAGUM, HON. ALLAN L. RELLON, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE SANGGUNIANG PANLUNGSOD A CONTRACT OF SERVICE WITH THE BAYAN ANG GABAY TELEVISION (BAGTV14) REPRESENTED BY ITS NETWORK MANAGER MR. GILBERTO A. GORGONIO.

WHEREAS, it is the right of every citizen in this City of Tagum to be informed of the legislative measures and development initiatives of the Sangguniang Panlungsod through the various programs, projects, and activities being legislated and implemented;

WHEREAS, radio broadcast is one of the fastest mediums for mass communication to the constituents of the city;

WHEREAS, by having a regular program in the conduct of regular and special sessions of the Sangguniang Panlungsod of Tagum, the people can easily avail information on the approved laws, react about certain policies and developments and be updated about programs and projects of the City Government of Tagum and other concerns and issues;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum City to authorize the City Vice Mayor of Tagum, Hon. Allan I. Rellon, to enter into and sign for and in behalf of the Sangguniang Panlungsod a contract of service with the Bayan ang Gabay Television (BAGTV14) represented by its Network Manager Mr. Gilberto A. Gorgonio.

RESOLVED FURTHER, that the full text of the Contract of Service shall be as follows:

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

The Contract is made and executed by and between:

The SANGGUNIANG PANLUNGSOD OF TAGUM, herein represented by the Honorable Allan I.

WHEREAS, in the light of recent developments of the locality there is a need for people to hear different opinions, especially from public officials – legislators for them to have extensive information and form insights about events and their significance in order for them to make objective decisions regarding their participation in their growth and development as an individuals and community;

WHEREAS, aside from hearing news and information through other forms of mass media communication, the people who will watch local TV programs highlighting the 4th City Council of Tagum will also have the opportunity to see concrete manifestations of good practices implemented by the legislative department, and they will have means of access to these programs, plans and other various activities that will benefit the entire populace through accurate information and could be possible understood and to know what the legislative department has been doing in response to the needs of its constituency; react to certain policies and developments; and be updated about programs and projects initiated by the Sangguniang Panlungsod of Tagum City;

WHEREAS, the PARTY OF THE FIRST PART has chosen PARTY OF THE SECOND PART, considering its extensive information and localized TV network in Tagum City, the center for commence in Davao del Norte;

WHEREAS, the PARTY OF THE FIRST PART is desirous to maximize Broadcast Media and provide the constituents of the city a tool and venue to interact and benefit from the city council's various plans and programs through an accurate dissemination of relevant information to the public through BAGTV14 which will also serve to enable the public to know and contribute to the formulation by encouraging listeners/TV audience to react and send their signatures;

WHEREAS, the PARTY OF THE SECOND PART will broadcast the City Council's Regular Session;

WHEREFORE, in view of the foregoing premises, it is hereby agreed:

1. That the PARTY OF THE SECOND PART will cover the City Council's Regular Session and Monday Convocation Program from October – December 2009 and will be produced/edited that will highlights only the important parts and will be played in the delayed telecast every Monday 8:00 P.M. and a replay every Tuesday 8:00 A.M. and Sunday "City Hour" every 9:00 A.M. including all the news items gathered from the City Hall in all BAGTV14 Branches (BAGTV Panabo, BAGTV Asuncion, BAGTV Sto. Tomas, BAGTV Maco ComVal Province, BAGTV Kapalong and BAGTV Davao) effective upon its approval;
2. That the PARTY OF THE SECOND PART will gather a news items from the City Hall everyday to be played in the daily Newscast "Balifa Karon" plus replay every 6:30 A.M. in all BAGTV branches;
3. That for and in consideration of the said service, the PARTY OF THE SECOND PART shall receive a package payment in the amount of Thirty Thousand (P30,000.00) Pesos broadcast package inclusive;
4. That the coverage of the regular session shall be in accordance with the format of the program in which it is run (BAGTV14). This will cover the City Councilor's session;
5. That this contract shall be effective for two (2) months covering the period of November 9 to December 9, 2009.
