RESOLUTION NO. 964, s-2009

“A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. REY T. UY, TO SIGN AND ACCEPT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF TAGUM, THE EXTRA-JUDICIAL SETTLEMENT OF ESTATE WITH DEED OF DONATION OF PARCEL OF LAND REGISTERED IN THE NAME OF MINDA RAFAEL LOCATED AT BARANGAY MAGUGPO SOUTH, TAGUM CITY, DAVAO DEL NORTE”

WHEREAS, Minda Rafael et. al. intend to donate a parcel of land to the City Government of Tagum in order that the same be maintained and sustained and for purposes of future development;

WHEREAS, it is the concern of the City Government of Tagum to accept donations such as open spaces, road lots and community facilities to complete and maintain the development of all facilities for the use of its constituents;

WHEREAS, this august body deems it proper to authorize the City Mayor to sign and accept, in behalf of the City Government of Tagum, the Deed of Donation of Lot 7121-D-3-B-8, Psd-11-086774, containing an area of 297 sq. meters;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Mayor, Hon. Rey T. Uy, to sign and accept for and in behalf of the City Government of Tagum, the Extra-judicial Settlement of Estate with Deed of Donation of a parcel of land registered in the name of Minda Rafael located at Barangay Magugpo South, Tagum City, Davao del Norte.
