RESOLUTION NO. 14, s-2010

“A RESOLUTION REQUESTING THE DAVAO DEL NORTE ELECTRIC COOPERATIVE (DANECO) TO FURNISH THE SANGGUNIANG PANLUNGSOD OF TAGUM THE FORMULA IN DETERMINING THE ANCILLARY CHARGES PASSED ON TO THE INDIVIDUAL CONSUMERS RELEVANT TO THE POWER RATE INCREASE.”

WHEREAS, it is the responsibility of every LGU to protect the interest and welfare of its constituents;

WHEREAS, in the First Regular Session of the 5th City Council, personalities from DANECO made mention that the cause of the sudden increase in the power rates is due to some ancillary charges;

WHEREAS, DANECO is requested to furnish copies of the detailed computation in the distribution of the ancillary charges among its consumers and further attach the factual basis of the said increase;

WHEREAS, it is but proper that the consumers be made aware of the details and rationale of the power rate increase;

WHEREAS, the overwhelming increase has enraged the Tagumeños especially in this time of economic crisis;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum, to request the Davao del Norte Electric Cooperative (DANECO) to furnish the Sangguniang Panlungsod of Tagum the formula in determining the ancillary charges passed on to the individual consumers relevant to the power rate increase;

RESOLVED FURTHER, that copies of this resolution shall be furnished to DANECO Board of Directors and Management and other Local Government Units in the Province of Davao del Norte and Compostela Valley within the franchise area of DANECO.
