**RESOLUTION NO. 15, s-2010**

**“A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE REY T. UY, CITY MAYOR TO ENTER, NEGOTIATE AND SIGN CONTRACT , AGREEMENT OR INSTRUMENTS RELATIVE TO THE PROJECTS/PROGRAMS SOLELY FUNDED BY THE NATIONAL GOVERNMENT.”**

**WHEREAS**, Section 25 paragraph ( b ) and ( c ) of Republic Act 7160, otherwise known as Local Government Code of 1991, expressly provides that; Consistent with the basic policies on local autonomy, the President shall exercise general supervision over local government units to ensure that their acts are within the scope of their power and functions;

1. National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in planning and implementation of the said national project;

2. The president may, upon request of the local government units concerned , direct the appropriate national agency to provide financial technical or other forms of assistance to the local government unit . Such assistance shall be extended at no extra cost to the local government unit concern.

**WHEREAS**, it is the concern of the implementing office /agencies as well as the members of the Sangguniang Panlungsod of Tagum that projects/programs solely funded by the national government should be implemented without further delays;

**WHEREAS**, since projects /programs are considered priority projects of the government which the approval of the corresponding Memorandum of Agreement and contracts thereof may be done frequently within the year round thus, there is a need for an authority of the City Mayor to represent and sign all agreements/contracts under projects/programs en masse or in one time basis within a certain period from August 2010 to December 30, 2010 to avoid repetition of the same nature of agreement /contract solely funded by the national government;

**WHEREAS**, Prior to the signing of the Memorandum of Agreement for a particular special project the said MOA must be reviewed by the City Legal Office and the same shall be forwarded to the Legislative Department through the Office of the City Vice Mayor for reference and review;

**WHEREAS**, after thorough discussion and deliberation during the plenary session, the august body agreed to authorize the Honorable Mayor to enter , negotiate and sign contract, agreement or instruments to the projects/programs solely funded by the national government;

**RESOLUTION NO. 15, s-2010**, cont'd:

**NOW THEREFORE BE IT RESOLVED**, by the Sangguniang Panlungsod of Tagum to grant authority to the Honorable Rey T. Uy, City Mayor to enter, negotiate and sign contract, agreement or instruments relative to projects /programs solely funded by the national government.

**RESOLVED FURTHER**, that copies of this resolution be furnished to Hon. Rey T. Uy, City Mayor, City Legal Office, City Budget Office, City Treasurer, City Accountant, City Planning and Development Coordinator and Commission on Audit, all of this city, for information and guidance.
