WHEREAS, it is the policy of the City Government of Tagum to ensure that the welfare of its officials and employees are always upheld;

WHEREAS, it is also the policy of the City Government of Tagum to provide its officials and employees not only moral but also financial and burial assistance during unavoidable events such as sickness, injury, accident and death;

WHEREAS, Macario Cutin, served as Punong Barangay of Barangay Magugpo West for eight (8) years;

WHEREAS, Macario Cutin, suffered Cardio Pulmonary Arrest which caused his death;

WHEREAS, the City Government of Tagum resolves to provide funeral and burial assistance to the immediate family of the late Macario F. Cutin, in the amount of TEN THOUSAND PESOS (P10,000.00), to help them in their expenses and in some way alleviate their grief;

WHEREAS, the source of funds shall be taken from the Awards and Indemnities;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum, to extend funeral and burial assistance to the immediate family of the late Macario F. Cutin, Former Punong Barangay of Barangay Magugpo West, in the amount of TEN THOUSAND PESOS (P10,000.00);

RESOLVED FURTHER, that copies of this resolution shall be furnished to the family of the late Macario F. Cutin and to all offices concerned for their information and guidance.
