RESOLUTION NO. 18, s-2010

“A RESOLUTION CONCURRING WITH THE RE-APPOINTMENT OF MR. RAFAEL E. ABRENICA AS CITY ADMINISTRATOR OF THIS CITY.”

WHEREAS, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of the Sangguniang Panlungsod Members subject to civil service laws, rules and regulations;

WHEREAS, in a letter dated July 13, 2010 addressed to the Honorable Members of the Sangguniang Panlungsod, Honorable Rey T. Uy, City Mayor, requested for a passage of a resolution concurring with the appointment of Mr. Rafael E. Abrenica as City Government Department Head 1 (City Administrator) of the City Government of Tagum;

WHEREAS, Mr. Rafael E. Abrenica had been appointed City Administrator effective July 01, 2007 until June 30, 2010 which was concurred by the Sangguniang Panlungsod as per Resolution No. 56, 2007;

WHEREAS, the appointment of an administrator is mandatory for all provincial and city governments, hence it becomes necessary in the public interest to concur with such appointment;

WHEREAS, the appointment shall take effect July 01, 2010, co-terminus with the appointing authority;

NOW THEREFORE, be it resolved by the 5th City Council of Tagum to concur with the re-appointment of Mr. Rafael E. Abrenica as City Administrator of this City.

RESOLVED FURTHER, that copies of this resolution shall be furnished to all offices concerned for their information and guidance.
