**WHEREAS**, the Local Government Unit of Tagum has appropriated funds for the incentives/allowances intended for the (10) ten prosecutors, under the general fund of the City Prosecutor's Office;

**WHEREAS**, with the rapid growth of the population of this city, the City Prosecutor's Office deems it necessary to increase the number of prosecutors who are willing and dedicated to serve the mandates of prosecution service;

**WHEREAS**, the three (3) additional prosecutors will have the same allowance as that of the ten (10) existing prosecutors;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to grant allowances for the three (3) additional prosecutors in the City Prosecutors Office from July to December 2010.
