RESOLUTION NO. 33, s- 2010

“A RESOLUTION INDORSING HON. OSCAR M. BERMUDEZ, CITY COUNCILOR AS SANGGUNIANG PANLUNGSOD REPRESENTATIVE TO THE PEOPLE’S LAW ENFORCEMENT BOARD (PLEB).”

WHEREAS, Article 187, Rule XXIII of the Rules and Regulation implementing the Local Government Code of 1991 mandates the establishment in every Local Government Unit of a People's Law Enforcement Board pursuant to the pertinent provision of RA 6975 known as the Act establishing the Philippine National Police under a reorganization Department of the Interior and Local Government and for other purpose;

WHEREAS, Section 43 of RA 6975 further provides that the People's Law Enforcement Board shall be its jurisdiction to hear and decide citizen's complaints or case filed before it against any erring officers and members of the Philippine National Police;

WHEREAS, the Sangguniang Panlungsod shall have a representative to be chosen among its members to the Law Enforcement Board as provided for in Section 2A of the composition of the PLEB as stated in the Manual of Procedure of the National Police Commission;

WHEREAS, there is a need for this august body to indorse a new SP Representative in the People's Law Enforcement Board due to the local elections held last May 10, 2010 , creating a new SP composition;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to indorse Honorable Oscar M. Bermudez , City Councilor as Sangguniang Panlungsod Representative to the People's Law Enforcement Board.

RESOLVED FURTHER that this Resolution shall take effect upon its approval.

RESOLVED FURTHERMORE, that a copy of this resolution be furnished to Hon. Rey T. Uy, City Mayor, Mrs. Eliza P. Mendoza, MPA, DILG City Director and the members of the People's Law Enforcement Board (PLEB).
