RESOLUTION NO. 1156, s- 2010

“A RESOLUTION GRANTING DEVELOPMENT PERMIT (DP) UNDER PD 957 OF FILINVEST HOMES PHASE 2 AS REPRESENTED HEREIN BY MR. ANTONIO CENON FOR A SUBDIVISION CONTAINING AN AREA OF 28,507 SQUARE METERS LOCATED AT PUROK PAG-ASA, BRGY. VISAYAN VILLAGE, TAGUM CITY.”

WHEREAS, the Office of the City Mayor has endorsed the application of Mr. Antonio Cenon, First Vice President of Filinvest Land Incorporated for approval of a subdivision development plan which includes documents required in the process of development permit on June 17, 2010 to this august body;

WHEREAS, the submitted subdivision plan satisfactorily complied with the minimum requirements set in Section 10, Rule 111 of the Revised Implementing Rules and Regulations for Medium Cost Subdivision as manifested in the Local Zoning Board Site Inspection and Evaluation Report dated May 17, 2010;

WHEREAS, Paragraph 2 (x) Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod subject to national law, to process and approve subdivision plans for residential, commercial or industrial purposes;

WHEREAS, it is incumbent to this august body to grant the Development Permit of the said applicant;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to grant the Development Permit under PD 957 to FILINVEST HOMES PHASE 2 as represented by Mr. Antonio Cenon for a subdivision containing an area of 28,507 square meters, located at Purok Pag-asa, Barangay Visayan Village, Tagum City.

RESOLVED FURTHER, that copies of this resolution be furnished to Mr. Antonio Cenon, First Vice President of Filinvest Land Incorporated, City Planning and Development Office, City Engineering Office and other offices concerned for their information.
